Personal Statement:

After I completed a TESL certificate in Victoria, Canada, I taught English with Ms. Glenn at the Taos Public Library. Ms. Glenn then encouraged me to complete my Bachelor's degree and pursue ESL and EFL as a career change. Teaching English to immigrants in my home town provided the sensitivity that is required to teach English as a Second Language. In October of 2007, I was hired by the Chungnam Office of Education, in South Korea. I taught at three public middle schools for one full year. In addition to teaching 26 class hours per week, I taught both at *Daecheon Girl's Middle School's Winter Camp*, and at Boryeong Summer Camp, open to all of Boryeong Middle School students. I particularly enjoyed teaching at *Daecheon Seo Middle School*, a public school for boys and girls together. I attended a workshop in Seoul presented by *Jack Richard's* on *Reflective Teaching* which has strengthened my skills. In 2008, I facilitated a bi-weekly teacher's group, lasting 16 weeks, for encouraging conversation and sharing teacher's knowledge. Teachers were mandated to attend. I am an effective co-teacher. I am able to work well with other teachers.
